**GENERAL DESCRIPTION OF CLASS**

The purpose of the class is to supervise assigned staff and provide difficult technical and responsible administrative support and work as an assistant to a department head. The class is responsible for staff supervision, and/or performing technical, organizational, and administrative, tasks. The class works within a general outline of work to be performed; develops work methods and sequences under general supervision.

<b>TYPICAL TASKS</b>	
<ul style="list-style-type: none"> <li>• Coordinates the operation of a division, bureau or major administrative or operating unit of the department.</li> <li>• Assists department heads in departmental organization, procedures and related problems.</li> <li>• Supervises subordinate personnel, including training, scheduling, assigning and evaluating work.</li> <li>• Provides administrative support to supervisor and other staff, including scheduling appointments and attendance at meetings, preparing documents and reports utilizing computer software.</li> <li>• Prepares and maintains operating budget for assigned area; monitors expenditures.</li> <li>• Resolves problems/issues and responds to customers in a timely manner.</li> <li>• Compiles monthly, annual and special reports.</li> <li>• Gathers and maintains information/data to support periodic and special reports documenting activities and events for area of responsibility.</li> <li>• Prepares and maintains records/files; processes daily paperwork such as correspondence, memos, requisitions, or personnel information; prepares and distributes periodic newsletter.</li> <li>• Coordinates/provides support services for Chesapeake citizens/families in need; analyzes needs, and plans special events, workshops, and seminars; facilitates prevention programs.</li> <li>• Maintains database and coordinates programs/operations for area of responsibility.</li> <li>• Evaluates departmental policy and procedures; makes revisions or develops new policy and procedures as required.</li> <li>• Attends or conducts staff and other professional meetings to exchange information.</li> <li>• Performs other related duties as assigned.</li> </ul>	

<b>GENERAL STANDARDS</b>	
<b>Data Involvement</b>	Gathers, organizes, analyzes, examines, or evaluates data or information and may prescribe action based on such data or information.
<b>Interpersonal/People Involvement</b>	Supervises others by determining work procedures, assigning duties, maintaining harmonious relations, and promoting efficiency.
<b>Reasoning Requirements</b>	Performs supervisory work involving policy and guidelines, solving both people and work related problems.
<b>Mathematical Requirements</b>	Uses basic algebra involving variables and formulas; computes discounts, rates, ratios, and percents.

<b>Language Requirements</b>	Reads journals, manuals, and professional publications; speaks informally to groups of coworkers, staff in other organizational agencies, the general public, and people in other organizations; composes original reports, training and other written materials using proper language, punctuation, grammar, and style; may present training programs.
<b>Mental Requirements</b>	Performs specialized technical or entry level professional work requiring general understanding of operating policies and procedures and their application to problems not previously encountered; applies specialized technical or professional principles and practices, or the use of a wide range of administrative methods in the solution of problems; requires normal attention with short periods of concentration for accurate results and occasional exposure to unusual pressure.
<b>Decisions/Supervisory Control</b>	Supervises others requiring the development of procedures and constant decisions affecting subordinate workers, staff, and others in the general public.

**EDUCATION, EXPERIENCE AND SPECIAL REQUIREMENTS**

<b>Vocational/Educational Requirement</b>	Requires any combination of education and experience equivalent to a bachelor's degree in business administration, public administration, or a closely related field.
<b>Experience</b>	In addition to satisfying the vocational/education standards, this class requires a minimum of four years of full-time equivalent experience in administrative support and supervision.
<b>Special Certifications and Licenses</b>	Depending on position, may require a valid driver's license in compliance with City driving standards.
<b>Special Requirements</b>	Employees may be expected to work hours in excess of their normally scheduled hours in response to short-term department needs and/or City-wide emergencies. Emergency operations support work and work locations may be outside of normal job duties.
