The Applicant/Owner also agrees to design, construct, maintain operate and close the Facility and restore and rehabilitate the Property in accordance with all requirements set forth in any conditional use permit or amendment thereto, which may be issued by City Council for the Facility, including all plans, plats, specifications and statements of intent made a part of, or related to, said conditional use permit.
- 2. If granted a conditional use permit for the Facility the Applicant/Owner shall defend, indemnify and hold the City harmless from and against all claims, liabilities, demands, charges, actions, proceedings, suits, damages, penalties, fines, expenses
