WHEREAS, the Chesapeake Electoral Board has determined that this change will not cause hardship or inconvenience to the affected voters; and

WHEREAS, this ordinance was considered by the Chesapeake City Council following a duly advertised public hearing in accordance with Virginia law.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Chesapeake, Virginia as follows:


1. Relocate the polling place for the current Georgetown Precinct (0012) from Indian River Middle School to Indian River Community Center. The voting place for all voters who reside within the following boundaries shall vote at Indian River Community Center, 2250 Old Greenbrier Road, Chesapeake, Virginia 23325:

Beginning at the intersection of the center line of the Norfolk & Southern Railroad and the center line of Providence Road; thence along the center line of Providence Road in a northeasterly direction to the center line of Rokeby Avenue; thence along the center line of Rokeby Avenue in a southeasterly direction to its intersection with South Military Highway; thence along the center line of South Military Highway in a southwesterly direction to its intersection with the center line of Norfolk & Southern Railroad; thence along the center line of the Norfolk & Southern Railroad in a northwesterly direction to its intersection with the center line of Providence Road, the point of beginning.

An emergency is deemed to exist, and this ordinance shall become effective upon its adoption.



The voting place for all voters who reside within the following boundaries shall vote at Alexander Baptist Church, 4316 Pamela Court, Chesapeake, Virginia 23321:

Beginning at the intersection of the center line of Goose Creek and the center line of Jolliff Road; thence along the center line of Jolliff Road in a northwesterly direction to its intersection with the center line of Bailey's Creek; thence along the center line of Bailey's Creek in a southeasterly direction to its intersection with the center line of the Western Branch of the Elizabeth River; thence along the center line of the Western Branch of the Elizabeth River in a southwesterly direction to its intersection with the center line of Goose Creek; thence along the center line of Goose Creek in a northwesterly direction to its intersection with Jolliff Road, the point of beginning.



Beginning at the point of the center line of Moses Grandy Trail and the center line of Dominion Boulevard, South; thence along the center line of Moses Grandy Trail in a northwesterly direction to its intersection with the center line of Deep Creek (waterway); thence along the center line of Deep Creek (waterway) in a northeasterly direction to its intersection with the center line of the Southern Branch of the Elizabeth River; thence along the center line of the Southern Branch of the Elizabeth River in a southeasterly direction to its intersection with the center line of Dominion Boulevard, South; thence along the center line of Dominion Boulevard, South in a southwesterly direction to its intersection with the center line of Moses Grandy Trail, the point of beginning.

An emergency is deemed to exist, and this ordinance shall become effective upon its adoption.

Beginning at the intersection of the center line of Greenbrier Parkway and the center line of Volvo Parkway; thence along the center line of Volvo Parkway in a southeasterly direction to its intersection with the center line of Fairways Reach; thence along the center line of Fairways Reach in a southerly direction to its intersection with the center line of Fairways Drive; thence along the center line of Fairways Drive in a southwesterly direction to its intersection with the center line of Greenbrier Parkway; thence along the center line of Greenbrier Parkway in a northerly direction to its intersection with the center line of Volvo Parkway, the point of beginning.

An emergency is deemed to exist, and this ordinance shall become effective upon its adoption.





NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Chesapeake, Virginia as follows:



Beginning at the intersection of the center line of the Interstate 464 Expressway and the center line of the Chesapeake Expressway; thence along the center line of the Chesapeake Expressway in a southeasterly direction to its intersection with the center line of a driveway; thence along the center line of a driveway in a southwesterly direction to its intersection with the center line of Great Bridge Boulevard; thence along the center line of Great Bridge Boulevard in a northwesterly direction to its intersection with the center line of the Interstate 464 Expressway; thence along the center line of the Interstate 464 Expressway in a northeasterly direction to its intersection with the center line of the Chesapeake Expressway, the point of beginning.

An emergency is deemed to exist, and this ordinance shall become effective upon its adoption.


