The board heard from a Provisional voter who was able to produce a receipt from the DMV acknowledging his Voter Registration application received on October 8, 2021 which was before the October 12, 2021 deadline to register to vote in the November 2, 2021 General Election. The board examined Provisional Ballots. There were 407 Provisional Ballots to process. After review and research were complete, 204 were determined valid, mostly due to absentee voting.
