

VOTING ABSENTEE IN CHESAPEAKE

Can I vote absentee?

Yes, if you are a registered voter and you will be absent on Election Day from Chesapeake because of the following:

- Student attending school
- Spouse of student attending school
- Business
- Personal business or vacation
- Active duty in the Merchant Marine or Armed Forces
- Spouse or dependent living with an active duty member in the Merchant Marines or Armed Forces
- Temporarily residing outside the U.S., cohabitant spouse or dependent
- Temporarily residing outside the U.S. for employment, cohabitant spouse or dependent
- First Responder
- Disability or illness
- Primary and personally responsible for the care of a disabled/ill family member confined at home
- Pregnancy
- Religious obligations
- Working and commuting to/from for 11 or more hours between 6:00 am and 7:00 pm on Election Day
- Confined, awaiting trial
- Confined, convicted of a misdemeanor
- An electoral board member, registrar, officer of election, or custodian of voting equipment
- Designated representative of candidate or party inside polls

How do I get the ballot?

Call, write or stop by the Registrar's Office located at 411 Cedar Road and ask for an absentee ballot application. The application is also now available at www.elections.virginia.gov.

When can I apply for an absentee ballot?

You can request an absentee ballot application as early as 12 months before an election. All applications for mail ballots must be received in the Registrar's Office no later than 5:00 p.m. on the Tuesday before the election date. The last date to vote an absentee ballot in person is by 5:00 p.m. on the Saturday before the election.

VOTING ON ELECTION DAY

Where will I vote?

When you register to vote your registrar will send you a voter information card. The card will tell you the name of your precinct and where you will vote. You must always vote in the precinct where you live.

What do I need to bring with me to vote?

Virginia law requires all voters to provide an acceptable form of photo identification (photo ID) at the polls. Acceptable forms of identification include:

- Valid Virginia Driver's License or Identification Card
- Valid Virginia DMV issued Veteran Military ID
- Valid United States Passport
- Other government-issued photo identification cards (must be issued by US Government, the Commonwealth of Virginia, or a political subdivision of the Commonwealth)
- Valid college or university student photo identification card (must be from an institution of higher education located in Virginia)
- Employee identification card containing a photograph of the voter and issued by an employer of the voter in the ordinary course of the employer's business
- Valid student ID issued by any institution of higher education located in the Commonwealth of Virginia
- or a Virginia Voter Photo ID Card obtained through a General Registrar's office

Any registered voter who does not possess one of the above mentioned forms of photo ID, may apply for a free Virginia Voter Photo Identification from any general registrar's office in the Commonwealth. Voters applying for the Virginia Voter Photo ID Card will have to complete the Virginia Voter Photo Identification Card Application, have their picture taken, and sign the digital signature pad. Once the application is processed, the card will be mailed directly to the voter.

A voter who arrives to the polling place without an acceptable form of identification will be given the opportunity to vote a provisional ballot. After completing the provisional ballot, a voter will have until noon on the Friday following the election to deliver a copy of the identification to the local electoral board. Voters may submit a copy of their ID via fax, email, in person, or through USPS or commercial postage service.

When are the polls open?

The polls open at 6:00 a.m. and close at 7:00 p.m. If you are in line when the polls close, you can still vote.

When do general elections take place?

For most offices, general elections are held on the Tuesday following the first Monday in November. For city and town offices, general elections take place the first Tuesday in May.

What is a party primary?

The Democratic and Republican parties can choose their candidates by either a primary election or by a party meeting. If a party uses a primary for the November election, it will be held on the second Tuesday in June. In Chesapeake, May elections (Council & School Board) are non-partisan; therefore, no primary is held.

Can anyone vote in a primary election?

If you are a registered voter, you can vote in any primary election since Virginia does not register by party. If both parties are holding a primary in your election district, you may only vote in one party's primary.
