

## **ATTENTION: CHESAPEAKE VOTERS**

Due to Decennial Redistricting, changes have been made to the following precincts and will be in effect for the November 8, 2011 Election and all future elections. All affected voters will be mailed a new voter card as required by the Virginia Election Laws 24.2-306.

0003 – The Camelot precinct located at Camelot Elementary School located at 2901 Guenevere Drive has been divided. The eastern portion of the Camelot precinct has been merged with the St. Julians precinct (0025) located at Moose Lodge #898 located at 1400 George Washington Highway, North. The remaining portion of the Camelot precinct will continue to vote at Camelot Elementary School located at 2901 Guenevere Drive.

0004 – The Churchland precinct located at Western Branch Primary School located at 4122 Terry Drive has been divided. The portion of the Churchland precinct that is south of the Drum Point Creek has been merged with the Fellowship precinct (0021) located at Point Harbor Community Church located at 2705 Taylor Road. The remaining portion of the Churchland precinct will continue to vote at Western Branch Primary School located at 4122 Terry Drive.

0012 – The Georgetown precinct located at Indian River Middle School located at 2300 Old Greenbrier Road has been divided. The southern portion of the Georgetown precinct has been merged with the Westover precinct (0033) located at Debaun Baptist Church located at 1510 Campostella Road. The northern portion of the Georgetown precinct will establish a new precinct which will be named Georgetown East precinct (0055) and will vote at Indian River Library located at 2320 Old Greenbrier Road. The remaining portion of the Georgetown precinct will continue to vote at Indian River Middle School located at 2300 Old Greenbrier Road.

0016 – The Hickory Grove precinct located at Butts Road Intermediate School located at 1571 Mt. Pleasant Road has been divided. The northwest portion of the Hickory Grove precinct will establish part of a new precinct which will be named Poplar Branch precinct (0063) and will vote at Great Bridge Middle School located at 441 Battlefield Boulevard, South. The remaining portion of the Hickory Grove precinct will continue to vote at Butts Road Intermediate School located at 1571 Mt. Pleasant Road.

0021 – The Fellowship precinct located at Point Harbor Community Church located at 2705 Taylor Road has been divided. The southeast portion of the Fellowship precinct has been merged with the Bailey Creek precinct (0038) located at Taylor Road Baptist Church located at 2509 Taylor Road. The remaining portion of the Fellowship precinct will continue to vote at Point Harbor Community Church located at 2705 Taylor Road.

0023 – The Oak Grove precinct located at Oscar Smith High School located at 1994 Tiger Drive has been divided. The northwest portion of the Oak Grove precinct will establish a new precinct which will be named Expressway precinct (0058) and will vote at River Oak Church located at 255 Great Bridge Boulevard. The eastern portion of the Oak Grove precinct will establish a new precinct which will be named Clearfield precinct (0059) and will vote at Grace Community Church located at 872 Clearfield Avenue. The remaining portion of the Oak Grove precinct will continue to vote at Oscar Smith High School located at 1994 Tiger Drive.

0027 – The Silverwood precinct located at Western Branch Middle School located at 4201 Hawksley Drive has been divided. The northern portion has been merged with the Taylor Road precinct (0035) located at Park View Christian Church located at 3201 Western Branch Boulevard. The remaining portion of the Silverwood precinct will continue to vote at Western Branch Middle School located at 4201 Hawksley Drive.

0034 – The Hickory Middle School precinct located at Hickory Middle School located at 1997 Hawk Boulevard has been divided. The northern portion of the Hickory Middle School precinct will establish a new precinct which will be named Centerville precinct (0061) and will vote at Centerville Baptist Church located at 908 Centerville Turnpike, South. The remaining portion of the Hickory Middle School precinct will continue to vote at Hickory Middle School located at 1997 Hawk Boulevard.

0035 – The Taylor Road precinct located at Park View Christian Church located at 3201 Western Branch Boulevard has been divided. The southern portion of the Taylor Road precinct will establish a new precinct which will be named Pughsville precinct (0054) and will vote at the Taylor Bend YMCA located at 4626 Taylor Road. The remaining portion of the Taylor Road precinct will continue to vote at Park View Christian Church located at 3201 Western Branch Boulevard.

0036 – The Great Bridge Baptist Church precinct located at Great Bridge Baptist Church located at 640 Battlefield Boulevard, South has been divided. The northern portion of the Great Bridge Baptist Church precinct has been merged with the Pleasant Crossing precinct (0043) located at 201 Stadium Drive. The southern portion of the Great Bridge Baptist Church precinct has been merged with the Hickory Middle School precinct (0034) located at 1997 Hawk Boulevard. The remaining portion of the Great Bridge Baptist Church precinct will continue to vote at Great Bridge Baptist Church located at 640 Battlefield Boulevard, South.

0037 – The Bridgetown precinct which was located at Great Bridge Community Center located at 212 Holt Drive has been divided and relocated. The southeast portion of the Bridgetown precinct will establish part of a new precinct which will be named Parker Road precinct (0060) and will vote at Great Bridge Community Center located at 212 Holt Drive. The Bridgetown precinct has been relocated to The Mount – Cathedral located at 215 Las Gaviotas Boulevard.

0040 – The River Birch precinct located at Greenbrier Intermediate School located at 1701 River Birch Run, North has been divided. The southwest portion of the River Birch precinct will establish part of a new precinct which will be named Cypress precinct (0057) and will vote at Unity Renaissance Church located at 1120 Eden Way, North. The remaining portion of the River Birch precinct will continue to vote at Greenbrier Intermediate School located at 1701 River Birch Run, North.

0042 – The Parkways precinct located at Greenbrier Presbyterian Church located at 1100 Greenbrier Parkway has been divided. The northern portion of the Parkways precinct will establish part of a new precinct which will be named Cypress precinct (0057) and will vote at Unity Renaissance Church located at 1120 Eden Way, North. The southwest portion of the Parkways precinct will establish a new precinct which will be named Green Tree precinct (0056) and will vote at Immanuel Baptist Church located at 1012 Battlefield Boulevard, North. The remaining portion of the Parkways precinct will continue to vote at Greenbrier Presbyterian Church located at 1100 Greenbrier Parkway.

0043 – The Pleasant Crossing precinct located at Great Bridge United Methodist Church located at 201 Stadium Drive has been divided. The northeast portion of the Pleasant Crossing precinct will establish part of a new precinct which will be named Poplar Branch (0063) and will vote at Great Bridge Middle School located at 441 Battlefield Boulevard, South. The southwestern portion has been merged with Coopers Way precinct (0051) located at The Bridge Christian Fellowship located at 1116 Hillwell Road. The southeast portion of the Pleasant Crossing precinct will establish part of a new precinct which will be named Fentress (0062) and will vote at Centerville AME Church located at 1116 Fentress Road. The southern

portion of the Pleasant Crossing precinct has been merged with the Hickory Middle School precinct (0034) located at Hickory Middle School located at 1997 Hawk Boulevard. The remaining portion of the Pleasant Crossing precinct will continue to vote at Great Bridge United Methodist Church located at 201 Stadium Drive.

0045 – The Sunray II precinct located at St. Mary’s Catholic Church located at 540 Homestead Road has been divided. The western portion of the Sunray II precinct has been merged with the Sunray precinct (0028) located at Sunray Community Center located at 353 Hertz Road. The remaining portion of the Sunray II precinct will continue to vote at St. Mary’s Catholic Church located at 540 Homestead Road.

0047 – The Green Sea precinct located at People’s Baptist Church located at 1200 Cedar Road has been divided. The southern portion of the Green Sea precinct will establish part of a new precinct which will be named Parker Road (0060) and will vote at Great Bridge Community Center located at 212 Holt Drive. The remaining portion of the Green Sea precinct will continue to vote at People’s Baptist Church located at 1200 Cedar Road.

0051 – The Coopers Way precinct located at The Bridge Christian Fellowship (previously named New Life of Great Bridge) located at 1116 Hillwell Road has been divided. The northern portion of the Coopers Way precinct will establish part of a new precinct which will be named Fentress (0062) and will vote at Centerville AME Church located at 1116 Fentress Road. The remaining portion of the Coopers Way precinct will continue to vote at The Bridge Christian Fellowship located at 1116 Hillwell Road.
