IMPORTANT TAX NOTICE FOR BUSINESS TAXPAYERS

Your Chesapeake Return of Business Tangible Personal Property and Machinery and Tools (Form #B123) for the taxable year is enclosed. Please refer to the instructions on the reverse side of the tax return before completing it.

DUE DATE: This tax return must be filed with the Commissioner of the Revenue's office on or before **March 1st of the tax year**. Mail postmarked by the U.S. Postal Service on or before the due date shall be accepted without penalty.

Extensions:

An extension of the filing date to April 15th of the tax year can be authorized only if Form #B124 on the back of this notice is returned to this office by March 1st.

PENALTIES: A penalty of 10% (\$10 minimum) will be added to the tax due if your return is filed after the required date.

Property to Report:

The return must include all personal property owned, leased, or in the possession of the business as of January 1st. Please include all motor vehicles used in your business. The reporting of leased property must also include the lessor's name and address.

Important! If you have gone out of business, please furnish the date the business ceased to operate. If you go out of business after January 1st of the tax year, you are still liable for the business tangible personal property tax. This tax is not prorated. After the property is assessed, you will receive a tax bill. The payment date for personal property taxes in Chesapeake is June 5th.

REQUEST FOR FILING DEADLINE EXTENSION
(FOR MACHINERY & TOOLS, BUSINESS AND FARM EQUIPMENT)

Important Notice To Taxpayers Filing Returns For Business Tangible Personal Property, Farm Equipment, and/or Machinery And Tools:

Chesapeake City Code Section 30-513 requires returns to be filed by March 1st of the tax year, unless an extension is authorized. If you need an extension to April 15th, complete this form and return it to the Commissioner of the Revenue's Office no later than March 1st of the tax year. A separate extension form is required for each account.
