**A site plan is required for all outside equipment. Load Calculations and Vent Certifications if applicable are required with permit application.**

The code official shall be notified when the construction reaches the stage of completion for an inspection. The permit holder shall assure that the inspections have been conducted and approved by the code official when applicable. A certificate of occupancy, indicating completion of the work for which a permit was issued, shall be obtained prior to any occupancy. I understand that the permit is granted for the work shown and described in this application. Any falsification, misrepresentation or misleading information given **VOIDS** the permit.

## MECHANICAL PERMIT FEE SCHEDULE

**MINIMUM FEE: \$40.00**

Fee shall be \$40.00 for the first \$1,000 in value, plus \$6.00 per each additional \$1,000 value or fraction thereof. A 2% of the total fee must be added for state levy. In addition of the permit fee and state levy, a \$5.00 technology fee is assessed.

\*Reinspection fee - \$35.00

## GAS PERMIT FEE SCHEDULE

For issuing each permit, the fee shall be \$40.00. In addition to the \$40.00 fee for issuing each permit, a fee of \$2.00 per gas outlet will be charged. A 2% of the total fee must be added for state levy. In addition to the permit fee and state levy, a \$5.00 technology fee is assessed.

**Processing of your application as quickly as possible is our goal. Please check the following to expedite this process:**

- **Is your site plan attached to your application for outside equipment?**
- **Is your state contractor's license and city business license up to date?**
- **Is your application complete, i.e., contract value, building permit number, class A, B or C circled?**
- **For your convenience, you may schedule an inspection online, 24 hours a day, 7 days a week.**
- **For your convenience, you may pay for your permit(s) online by check, credit or debit card.**
- **Is your vent certification form attached for all fuel fire equipment/chimney liner replacements?**
