Participants 18 years of age & over, complete parts A and B.** In consideration of participating in any way in the May 7, 2022, Dismal Swamp Canal Paddle for the Border Event, herein referred to as "the event," each of the undersigned, for himself or herself, his or her personal representatives, heirs, next of kin, agrees to the following:

### PART A: PHOTO/MODEL RELEASE

For and in consideration of my engagement as a model by Dismal Swamp Canal Welcome Center, Camden County, the Chesapeake Parks, Recreation and Tourism Department, and US Army Corps of Engineers, hereafter referred to as the photographer, on terms or fee hereinafter stated, I hereby give the photographer, their legal representatives and assigns, those for whom the photographer is acting, and those acting with their permission, or their employees, the right and permission to copyright and/or use, reuse and/or publish, and republish photographic pictures or portraits of me, or in which I may be distorted in character, or form, in conjunction with my own or a fictitious name, on reproductions thereof in color, or black and white, made through any media by the photographer at their studio or elsewhere, for any purpose whatsoever, including the use of any printed matter in conjunction therewith.

I hereby waive any right to inspect or approve the finished photograph or advertising copy or printed matter that may be used in conjunction therewith or to the eventual use that it might be applied. I hereby warrant that I am **(circle one) under / over eighteen years of age** and competent to contract in my own name insofar as the above is concerned. There will be no compensation for the use of my photo or photos. I hereby release, discharge and agree to save harmless the photographer, their representatives, assigns, employees, or any person or persons, corporation or corporations, acting under their permission or authority, or any person, persons, corporation or corporations, for whom they might be acting, including any firm publishing and/or distributing the finished product, in whole or in part, from and against any liability as a result of any distortion, blurring, or alteration, optical illusion, or use in composite form, either intentionally or otherwise, that may occur or be produced in the taking, processing or reproduction of the finished product, its publication or distribution of the same, even should the same subject me to ridicule, scandal, reproach, scorn or indignity.

**THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made. This release, waiver and indemnification agreement specifically embraces each and every phase of the event sanctioned, authorized, offered and/or promoted by said releasees during the entire event and applies to every activity and/or service of the event herein mentioned, and has the same effect as if executed after each and every activity of the event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to the entire event hereinabove described.
