All Blue Heron Sponsors agree to be legally bound by the following terms and conditions:

1. The City of Chesapeake Symbol Committee (also known as The Blue Heron Project), herein after referred to as the Committee, reserves final determination on placement of Sponsored Heron statues and on time period of exhibition.
2. Sponsor will be provided with a portfolio of artists rendering's from which they may select Blue Heron designs, or Sponsors may commission an artist independently. **All designs must be approved by the Committee.** Please indicate preference below:
 Sponsor will choose a pre-approved design
 Sponsor will commission their own design
3. If Sponsor chooses to redecorate their Blue Heron statue after installation, it will be at the Sponsor's expense. The new design must be approved by the Committee.
4. If damage to the Blue Heron statue occurs, the Committee will not be responsible for repairs. Sponsor must make arrangements with artist to maintain sculpture and keep it in good repair.
5. In the unlikely event of theft, the Committee will work with appropriate law enforcement agencies to recover the Blue Heron statue and/or prosecute perpetrator(s) to the fullest extent of the law.
6. Sponsor may not transfer or assign this Adoption Agreement or any part of it without receiving prior consent from the Committee.
7. In the event of abandonment, Blue Heron statues will become property of the Committee.
8. Any modification or waiver of any term or condition in this agreement will not be effective unless submitted in writing and signed by both parties.
