Planning Department Public Hearing Schedule and Development Application Deadlines:

Please find the Chesapeake Planning Department 2017 Public Hearing schedule within this development advisory notice. The full schedule can also be found on our website.

The following changes will be effective January 2, 2017:

- The Planning Department will only be accepting development applications electronically through **eBUILD**. Planning staff and computer kiosks are available to assist customers with filling out an application online in eBUILD.
- New application submittal due dates are 10 days prior to that month’s Planning Commission meeting.
- All notarized and originally signed paperwork shall be due the Friday prior to date the Application is Certified for Public Hearing.
- Preliminary proffer statements may be signed either the applicant OR owner.
- Final proffer statements shall be signed by BOTH the applicant AND owner.
